The Trustee follows the directions of the Employer, **Cape Bancorp Inc.** (the "Employer"), or other parties designated in the trust agreement between the Employer and the Trustee, with respect to voting and disposition of shares. The Trustee, however, is subject to fiduciary duties under ERISA. The Trustee disclaims beneficial ownership of the shares of common stock that are the subject of this Schedule 13G.
- (b) The **1,076,670** shares of common stock represent **7.95%** of the Issuer's outstanding shares of common stock. The percent of class is based on shares outstanding as of December 31, 2015, as provided by the Issuer.
